Explanatory Note

The Compulsory Purchase (Inquiries Procedure) Rules 2007

Rule 10 – Date of inquiry.

Rule 10(1)(a) states that the date fixed by the authorising authority i.e. the Secretary of State, shall be, in the case where there is no pre-inquiry meeting, not later than 22 weeks after the relevant date.

Rule 10(1)(b) states that the date for the holding of an inquiry, in a case where a pre-inquiry meeting (or where there is more than one, the final pre-inquiry meeting) is held pursuant to rule 4 i.e. at the instigation of the authorising authority or rule 6 i.e. at the instigation of the Inspector, will be not later than 8 weeks after the conclusion of that pre-inquiry meeting.

In this case the pre-inquiry meeting is scheduled to take place on 19 November 2014 and the Inquiry will be opened on 20 January 2015 which is 6 days outside the 8 week window. This is due to the fact that the pre-inquiry meeting has been instigated by the Inspector because she feels one is necessary in order to ensure the smooth running of the inquiry and to minimize the risk of it over-running the 8 days assigned to it. However, the Inspector's work programme is such that she is unable to incorporate the pre-inquiry meeting into it so as to comply with Rule 10(1)(b) - the 8 week rule.

Rule 10(1)(c) states that where the authorising authority is satisfied that in all the circumstances of the case it is impracticable to hold the inquiry within the period mentioned in sub-paragraph (a) or (b) (as the case may be), the earliest practicable date after the end of that period.

In light of all of the foregoing the Authorising Authority has confirmed that the Secretary of State is exercising the power conferred by Rule 10(1)(c) to waive the 8 week rule because he is satisfied in all the circumstances of the case that it is impracticable to hold the inquiry within 8 weeks from the date on which the pre-inquiry is held.
