#### **Agenda Item 11 – Regeneration estates essential major works programme; discounted resident leaseholder charges**

And

#### **Agenda Item 12 – West Hendon Regeneration Project**

Firstly I submitted approx. 109 questions and information requests.

On the evening of the meeting although I arrived well before 8:00pm I was not allowed up to the committee room until after 8:00 pm.

I eventually gained access at approx. 8:10 pm and proceeded to prepare myself to answer the 20 permitted questions.

At approx. 8:25pm I was given a 76 page document and informed that it was the council's replies to my above mentioned questions and information requests.

At approx. 8:30pm I was requested to address the committee.

I sat down and put my first question to the committee only to be told that I was supposed to be going through the 76 page documentation that I had only just been given.

To my relief the Chair Councillor AA conceded to my request to follow my own documentation as I stated that I had only just been given the 76 page document minutes before being requested to speak and had not had a chance to even glance at it, let alone read it and was unable to reply to it.

During the entire meeting I put every effort into presenting the facts as I knew them to what at best can be referred to as a complete committee of unknowledgeable persons who right from the start had not a clue as to what I was talking about or what actual issues that I was referring to.

*I found this not only very disconcerting, but also very worrying as these persons were elected to look after our communities best interest and safe guard our future, Clearly from the responses' I got they were all incapable of doing either.*

*This is very worrying for me and the entire **West Hendon Community**.*

### **Item 11 on the Agenda**

As I proceeded to engage the committee with intelligent and informative dialogue I was reciprocated with the complete opposite.

Every time I presented a factual statement it was met with either zombiefeid surprise or scripted rhetoric monologue.

I attempted to present the facts in an honest attempt to allow all the councillors to make a much more informed decision that would at least reassure the **West Hendon Community** that LBB was actually listening to them.

Instead several of the councillors treated me with complete and utter contempt and paid little to no attention to me let alone the facts that were being presented to them.

Councillor Ram played on his electronic rude box and did not put it down until he was instructed several times by the chair to do so and he still took little and no notice of what was being presented.

The Chair councillor AA only enforced his instruction after numerous requests from the audience raised their objections about councillor Ram persistent blatant rude contemptuous behaviour towards me.
