


SURVEY SHOWS HIGH SATISFACTION RATING FOR RESIDENTS' MOVES



Gadwall and Bullfinch House

Over 95% of residents who have already moved into Gadwall and Bullfinch House said they are either "satisfied" or "very satisfied" with the quality of their new home.

Residents who recently moved were asked by Barratt Metropolitan LLP to provide feedback on their new home and their experience of the moving process.

Of the 57 out of 69 households that responded, 91% said they were either "satisfied" or "very satisfied" with their move. The survey is now closed. This feedback will be used to plan for future phases and will be shared with West Hendon Partnership Board members in future meetings.

UPDATE ON CPO PUBLIC INQUIRY

As you may be aware, the Secretary of State is currently reviewing the Compulsory Purchase Order report, written by the planning inspector following the Public Inquiry earlier this year. Generally, a decision is expected within 13 weeks, however, it can take six months or more. All those affected will be informed of the decision as soon as the outcome is known.

In the meantime, Barnet Council is continuing with private negotiations, and CPO consultants, GVA, recently held a meeting with leaseholders to talk about the offer and the situation as it stands. Negotiations are progressing well, with a number of leaseholders beginning to sell their properties to the Council and buying into the shared equity scheme.

Relocation of secure and non-secure tenants is also progressing in a timely manner. Barnet Homes have now rehoused all non-secure tenants with only three secure tenants yet to relocate.
